News from the Trustee Directors

Our Board meeting was held virtually on 12th September.

Policy Updates

The Board approved updates to our GDPR Privacy Notice - Members and Volunteers. Our Volunteer Handbook has now been updated to contain this and our Covid Guidelines for Visiting. Our Therapet Risk & Control Register, and our Therapet Visiting Risk Assessments have also been updated to reflect the current situation.

Commercial and Non-commercial Movements of Pets Into Great Britain

Our Animal Health, Education and Legislation Committee have submitted a response to the recent DEFRA consultation on pet travel and imports to the UK. In June, the Animal Welfare (Kept Animals) Bill was introduced to parliament to outline restrictions on both commercial and non-commercial movement of pets on welfare grounds and to support enforcement of existing rules. The proposed measures include

- Increasing the minimum age at which dogs can be brought into Great Britain
- Prohibiting movement of dogs with cropped ears and docked tails
- Prohibiting movement of heavily pregnant female dogs

Statement of Fitness Forms

You should have received a copy of our Pathway Document by email and/or post. This contains our Statement of Fitness for both Therapet and volunteer. The volunteer statement is for insurance purposes to ensure that, at time of signing, you are not displaying any symptoms of COVID 19 and that you are aware that should you test positive you must not visit!

The Therapet form is to ensure that you remain confident that your pet is still in good health and retains a suitable temperament to continue its role as a Therapet and remains on a non-raw food diet. Your Therapet's vaccinations (or titration tests), and parasite regime as directed by your vet need to be up to date before your pet resumes Therapet visiting.

Please note that we need a signed copy returned to our office (by email or post) before you will be able to undertake any Therapet visiting. If you need a new copy of this form, please contact the office.

Pet Health – Travelling in Cars

As a reminder, now that we are travelling more frequently than in the last year, it is a legal requirement across the UK to ensure that all animals are secure during travel. In the Highway Code, Rule 57 states 'When in a vehicle make sure dogs or other animals are suitably restrained so they cannot distract you while you are driving or injure you, or themselves, if you stop quickly. A seat belt harness, pet carrier, dog cage or dog guard are ways of restraining animals in cars.

Touching Tribute

A lovely reminder from Gillian Leung on the third anniversary of Tess's death that although our Therapets may be gone, they are never forgotten!

'Tess the Therapet'

Tess had a love for life and people which shone out of her. Tess made friends quickly with everyone she met which made her the perfect Therapet. Our main Therapet visits took place in a care home in the southside of Glasgow. Many of these residents had dementia or were immobile but their faces lit up as soon as Tess arrived. The residents spoke to Tess, enjoyed stroking her and giving her the occasional treat. There was a palpable difference in the atmosphere when Tess was there – and the care home staff also seemed to benefit from our visits. The residents enjoyed hearing all about Tess's other adventures including long walks, trips away with us and competing in agility competitions.



We also participated in 'Paws against Stress' where Tess visited universities during exam time to help alleviate student anxiety. One student from overseas was particularly memorable as Tess reminded her of the dog she was missing at home. Tess instinctively knew how people were feeling and seemed to gravitate to this student and make her feel better.

Tess gave her love freely and willingly to everyone she met, and I am so glad we shared the Therapet experience together.
