### BULLETIN 94 - January 2019

Dear Members and Friends,

Happy New Year!

Our 2018 Awards Lunch took place on Sunday 25th November at the very welcoming and dog friendly Marriott Hotel in Edinburgh. In addition to the awards, we were celebrating CCST's 30th anniversary. It was in 1988 when Marjorie Henley Price, along with four other Trustees, established the Trust, and with a small band of dedicated volunteers started the Therapet Service and the educational programme on responsible dog ownership.





A special cake for the occasion was baked by Mick Stead

and was cut by our Patron Rosemary Long, watched over by yours truly. At the start of the lunch Chairman of Trustees Allan Sim welcomed everyone, gave an update on the work of the Trust, and outlined future developments, some of which are summarised later in this Bulletin.

The **SPENCER AWARD for THERAPET OF THE YEAR** was donated by **Tom and Dorothy Wilkins**, whose Cavalier King Charles Spaniel, **SPENCER**, was the very first dog to be registered in the Therapet service, way back in 1988. As always, the voting was very close but, the award for 2018 was won by **CORRIB**, a

In her nomination Catherine wrote:

"Corrib and I enjoy the experiences we have operating for the Therapet Service for Canine Concern Scotland Trust in various roles. We spend wone morning every fortnight in Ward 36 (older adult acute mental health) at the Royal Alexandra Hospital, Paisley spending time with patients who have dementia.

We spend some time every fortnight with a non-verbal adult with learning difficulties from the Richmond Fellowship.



"Every week during term time we spend a morning with children involved with the Reading With Dogs programme at Arkleston Primary School in Renfrew. We participate when required in the Paws Against Stress events at various universities. There are varied demands placed on Corrib in these roles but he copes very well and adapts to the demand with both the younger and older clients. At home he is a playful dog who enjoys long walks, swimming and a good game of tug!! He is a strong dog but when he puts on his Therapet jacket it is as if he knows that he has to be calm. gentle and responsible.

"Corrib and I have had many memorable experiences from these various roles. The role we play is always very rewarding and our experiences always leave me uplifted. As he is still a young dog Corrib's reward is a good long walk at the end of sessions with a good swim! Various patients have formed strong attachments to Corrib – one discharged patient was so attached that I felt we should visit him in his nursing home. The primary school has claimed him as an "Arkie" dog and has invited him to Christmas and end of term shows, which he thoroughly enjoys as he is treated like a VIP guest! Corrib was invited to attend the Volunteer Thank You party at the RAH recently celebrating 70 years of the NHS and 80 years of the RVS volunteers. Some of the Arkleston pupils have now left but have enjoyed Corrib's visits so much that they have requested that he continues working with them in high school."

Nominations forms with glowing commendations were received from Ward 36 Royal Alexandra Hospital, Richmond Fellowship, Dykebar Hospital and Arkleston Primary School.

The Runner-up for Therapet of the Year was Noodle, a Beagle, owned and nominated by Amy McKenzie, also of Aberdeen. In her submission Amy wrote:

"I am so incredibly proud of the wonderful work Noodle has done over the last year.. Not only is she visiting a care home fortnightly and primary and academy weekly, but she also does a lot of work with the Paws Against Stress Scheme. Noodle visits Pitmedden Primary School, Auchtercrag Care Home, Inverurie Academy, Scotland's Rural College, Robert Gordon University, Causeway View and Shared Lives."

Letters of commendation from Pitmedden School, Auchtercrag Care Home, and Inverurie accompanied the Noodle's nomination.

The Second Runner-up for Therapet of the Year was Bruno, a German Shepherd Dog, owned and nominated by Fiona and Peter Watts of Aberdeen. In his submission Peter wrote:

"I am putting Bruno forward for the Spencer Award because of great good nature, ability to quickly switch from play to calm and general unflappability, backed by a busy visitation schedule, and that he has covered virtually all the types of work done by Therapets."

- Attended 55 Reading With Dogs sessions covering 8 schools
- Attended 6 schools for Talks & Presentations
- Made 28 Therapet visits
- On 28 occasions assisted in phobia treatment

Norma became a Therapet Volunteer in 1998 with her beloved **Simba** who was a rescued Llasa Apso. In 2000 she became our Area Representative for Tayside, which included Perthsire as well as Dundee & Angus which is the area she now looks after. Norma has worked tirelessly over the last 18 years looking after her team of Therapet volunteers.

In most years she invited her volunteers, and their Therapets, to her home in Friockheim for a garden party – a great way for the volunteers to get to know each other. As well as the regular work of carrying out assessments of potential Therapets, and of arranging for them and their owners to visit, Norma was frequently giving talks to interested and diverse groups about responsible dog ownership and the benefits of the Therapet Service. In 2016 Norma was invited to join the Board of Trustees.

Sadly for all of us Norma has decided to retire. In fact she retired from the Board at the end of August and will retire as Area Representative at the end of December. It was very appropriate therefore to present her with the Iain Whyte Memorial Award as an expression of sincere thanks for all that she has contributed to Canine Concern Scotland Trust and the Therapet Service.

If you are certain that you qualify please do sign the declaration as the Trust can then recover valuable tax from HM Revenue & Customs. Please complete the form and send it to the office along with a cheque made payable to Canine Concern Scotland Trust.

You will see from the form that it is possible to make payment directly to the Trust's bank account. If you decide to use this method, please ensure that you instruct your bank to give your **surname and initial** as a reference. Additionally, if you make direct payment please remember to send us the completed renewal form if you want Gift Aid to apply.

### **RAW MEAT BASED DIETS**

In the April 2018 Bulletin I advised members that the Trustees, after careful consideration, had decided on a new policy to the effect that with from 1st January 2019 Therapets should not be fed on raw meat based diets. This is in accordance with the protocol issued earlier in 2018 by the Royal College of Nursing **"Working with Dogs in Health Care Settings"** to support organisations considering working with dogs in health care settings and allied health environments. Needless to say the Trustees very much regret losing some Therapets because of this policy, and send their thanks to the volunteer owners, whose Therapets are affected, for their participation in the Therapet Service.

A copy of the current version of the Therapet Health protocol is included on the back of this bulletin.

We send our sympathies to you all, along with our sincere thanks for sharing your pets with so many people by your participation in the Therapet Service. If I have not mentioned any Therapets that have died recently please let the office know.

Whilst he was too lively to be a registered as a Therapet I must mention that my Boxer **ZAK** died in September. The last in a long line of Boxers! It all started in 1956 when my Father and Mother brought home a Boxer puppy called **PUNCH** from Dymchurch in Kent. Moving on a few years Marjorie and I agreed (or rather I insisted!) that when she was able to stop work we would have a dog and that it would have to be a Boxer dog puppy, red to replicate Punch.



Marjorie had never had a dog in her life before! Well, in 1970 a six month old brindle bitch called **HOLLY** came into our lives from Loch Lomondside. Little did we realise what would materialise in the coming years. It is all recounted in Marjorie's book "Sprigs of Holly" but to summarise, without Holly, and what she meant to Marjorie, Canine Concern Scotland Trust would not have come into existence. To cut a long story short, our last Boxer Zak came to live with us in Machrihanish in December 2006 and in the last years of her life he was Marjorie's true Therapet and companion.

### **AREA REPRESENTATIVES**

We are delighted to welcome recently retired vet **Stewart Donald** as our Representative for Inverness and Nairn. In addition to his immediate area, Stewart has willingly agreed to cover East Sutherland and to look after Lochaber and Skye in the west.

In Dundee & Angus following the retirement of Norma Murray, after many years of service, I am pleased to report that **Margaret Pengelly and Kerry Roberts** have become joint Representatives for the area.

We are also delighted that in Aberdeen, Diane Wood and Fiona Watts are being joined by **Carole Ledingham**. Apart from being an enthusiastic Therapet volunteer, Carole brings with her bags of relevant experience gained in the NHS from which she recently retired.

In Edinburgh & The Lothians we welcome two new Representatives, **Janet Jones and Sarah Bond**. Janet is to take over part of Derek Muir's very busy area by taking on Edinburgh North East and Derek is continuing to serve Edinburgh North West. **Sarah Bond** is becoming responsible for Edinburgh South, succeeding Cynthia Jeffries, who is moving from the area she covers. Cynthia has done a great job in Edinburgh South and Midlothian and fortunately we will not be losing her completely as we hope that when she is settled in her new home she will assist Simon Young in East Lothian. Hopefully by the time you read this a Representative for Midlothian will be in place. Finally, Barry Williamson in Edinburgh West is extending the area he covers by taking more of Edinburgh South West. When everything has settled down, we will be writing to all members in Edinburgh & The Lothians to clarify which Representative is responsible for them.

### **DEVELOPMENTS**

During 2018 the Trustees have been carrying out a review of the Trust and how it operates. Whilst the review remains ongoing I can advise you of the following developments:

- 1. In the office, Carole Dryburgh will be moving to full-time employment with effect from 1 January 2019. This change will have two major beneficial effects:
- a) It will increase our administration capacity
- b) It will mean that the office will be "open" for more hours each day. The telephone will be "on" between the hours of 10.00am and 4.00pm except when Carole is on annual leave when we will revert to 10.00am to 1.00pm.
- 2. We intend to recruit a new full-time employee with the title of Support & Development Officer. The role will include more support, where it is required, for our Area Representatives than has been possible hitherto. The new employee will work closely with James Macdonald in his capacity of Chair of the Therapet Committee, and with me in respect of my CEO role.

You will see that I have set out below more detailed information about the post. If you, a member of your family or a friend would like to apply please let me know.

- 3. We are about to embark on a major revamp of our IT arrangements. This will involve the replacement of the existing Microsoft Access database with a new cloud based management system which can be developed to meet Trust's administrative needs much more efficiently, thus improving the communications and service that we give to our members and volunteers
- 4. We are going ahead with a remake of our educational Children and Dogs video. It will be made by a media company in Aberdeen.

### Job Vacancy: Support and Development Officer

The core work of this post will be support and assistance to Area Representatives managing the Therapet Service of **Canine Concern Trust Scotland**. Key aspects of this work will be organisation and management, and liaison between volunteers, Area Representatives, the Board of Trustees, the C.E.O., and client organisations. This will include garnering suggestions for development and improving the service, and helping to implement changes as needed. Specific help is required with management and administration of the PAWS (Paws Against Stress) and Reading with Dogs programmes. The work also includes general PR work, compiling a short Bulletin for members three times a year, giving occasional talks to interested groups, and involvement in other promotional work. A full job description can be provided on request. The post is full-time for a period of two years which will include an initial probationary period six months. However, there is also potential for rapid promotion to a senior position for a successful and effective

#### THERAPET NEWS

During 2018 another record number of new Therapets were registered. At the time of writing in mid December the total exceeded 250. A big welcome to them all and to their owners! We hope that you are enjoying participating in the Therapet Service and that you will keep in touch with your Area Representatives and with Lesley, Norma and Carole in the office. They are all there to give whatever assistance and advice you need.

#### **READING WITH DOGS & PAWS AGAINST STRESS PROGRAMMES**

The demand for these programmes continues to grow and your Area Representatives will be very pleased to hear from you if you would like to consider participating in either or both.

Our **Reading With Dogs** programme is expanding all the time. The aim of this project is to try to encourage young readers who lack confidence with reading to come along to a library/school and, instead of reading to a person, read to a dog. The idea being that the dog will listen to them and not judge, allowing them to relax and gain confidence in reading out-loud. Our leaflet sets out the aims of the initiative, and the important guidelines for organising sessions. Of particular importance is the section dealing with those who must be present at sessions. If you would like copies of the leaflet please let the office know.



We point out when new Therapets are registered that they must have been visiting adults regularly for a year before they can be considered for visiting with children. A new assessment as regards their suitability must be carried out. Additionally we have to ensure that Members' PVG registrations include work with children for CCST.

To meet demand we do need more Therapets to be available in all areas of Scotland. If you are interested in participating in the programme with your Therapet please get in touch with your Area Representative or the office. Please bear in mind that there is an increased level of commitment in that typically a series of six sessions will be held at a school over a period of six weeks. Naturally individual schools will have their own requirements and these will be discussed at the outset. Sessions are for up to two hours as explained in the leaflet.

The **Paws Against Stress** programme is mainly aimed at students in universities and other institutions of further education at exam time to give them relaxation with interaction with our Therapets and our volunteers. Because of the number of students involved we have a team of Therapets at each session. In addition to being outgoing and friendly towards the students, the Therapets must also get along with each other!

The sessions are useful occasions for volunteers to get to know each other.

I am currently collating statistics from our Area Representatives regarding the activity in both programmes in 2018. ### **KEEPING YOUR THERAPET HEALTHY – DOGS**

The Therapet is almost by definition going to meet and bring comfort and happiness to people who are not in the best of health, and whose immune systems may be weak either through disease or in some cases because of the treatments which they are receiving.

It is the duty of every Therapet owner to ensure that their Therapet is in the best of health, and not going to take germs into the environment of those we are visiting. We must be able to convince the authorities in charge of hospitals, homes or schools that we have taken every precaution to ensure that our Therapet is safe and can only bring benefits to those whom we visit.

CANINE CONCERN SCOTLAND TRUST ask all Therapet owners to take the following health precautions.

• Annual Health Check. All Therapets must have an annual health check-up by your own veterinary surgeon. You must inform your vet that your dog is a Therapet and will be visiting people who may be in poor health and whose immune system may be compromised either by disease or therapy. Ask your vet's advice as to what vaccinations your Therapet would require. If it is decided that no vaccine should be given then we would ask that your Therapet is tested every three years to assess your Therapet's level of immunity against the major dog infections. We would advise you to consider including a Kennel Cough Vaccination into the programme of vaccination.

You should in particular ask your vet to check for any signs of ear, eye, nose or mouth infections (including dental disease) and ensure that the coat is clear of any signs of skin disease. Remember these are the parts of your Therapet with which the people you are visiting will make direct contact.

- Deworming against both round and tape worms must be undertaken at least every three months, and monthly if your Therapet is visiting schools or youth groups.
- · Skin Parasites. You must protect your dog against fleas and ticks..
- Passport Dogs. If your Therapet has been abroad in the past 12 months it may require a special treatment for ticks and worms check with your vet.
- Regular dental checks to stop smelly breath and the risk of spreading infections through saliva.
- Regular ear checks. Ear infections can be painful if someone pats your dog's head and infection could be passed to a human
- All Therapets who are unwell should be withdrawn from duties until back to normal, or until professionally cleared if veterinary treatment was required. Therapet owners should not visit if they are unwell.
- Raw Meat Diets. In the light of recent scientific evidence that Raw Meat Based Diets may contain pathogenic bacteria and parasites which could infect dogs and possibly in rare circumstances pass to those in contact with the dog, Canine Concern Scotland have decided that Therapets should not be fed a raw meat based diet. We shall keep this matter under review and if scientific evidence states that RMBD are safe and free from risk of causing infection we shall reconsider our decision.
